GUEST LECTURE ON "ANTI RAGGING: PPREVENTION, REGULATION AND PUNISHMENT" 20 th September 2016

Continuing its tradition of organizing guest lectures on different subject being aware of the significance of making the students aware about the importance of ragging and its prohibition, a guest lecture on the theme of anti-ragging was organized on 20/09/2016. Gujarat high Secretary P.S.Rathod and distinguished lawyer Mr. Rajubhai Desai were invited to address the students. Initially floral well come was given to invited guests. In the beginning of lecture 30 minutes documentary film was shown to the students on Ragging. Gujarat high Secretary P.S.Rathod delivered a lecture on the topic "ANTI RAGGING: PPREVENTION, REGULATION AND PUNISHMENT." He gave interesting examples of how the relationship was used to be build up between seniors and juniors in ancient India. He illustrated the present scenario and explained legal provisions banning the practices of ragging in India. In the process he very lucidly highlighted all the landmark cases pertaining to ragging delivered by various High Courts and the Supreme Court of India. He emphatically reiterated the reasons for why ragging should not at all be tolerated at any cost. He submitted that any person with the iota of sound logic will agree that there are many other civilized ways for bringing the fresher's in to the mainstream of the campus life. He then encouraged students to hold a variety show program after the academic sessions for juniors and seniors. The lecture was very well received by the students and the actively participated in the post lecture question and answer session wherein their deep interest in the topic was clearly exhibited.

The distinguished lawyer Rajubhai Desai told the students how the practice of ragging is incongenial and harmful for students. If fosters negativity. He also emphasized the lagal implications of ragging that it is a punishable offense by law and

the offender can be fined and imprisoned.

Principal Dr. Vikas Desai explained to the students how ragging should not be practised as it demoralizes a students and is inhuman. Instead new students

should be welcomed cordially and given help in all possible ways.

Vice Principal Dr.T.G.Gohil told Ragging is completely prohibited in college and anyone found guilty of ragging and / or abetting ragging whether actively or passively, or being a part of conspiracy to promote ragging, is liable to be punished in accordance with UGC Regulations 2009 as well as under the provisions of any penal law for the time being in force.

Finally all the students pledged not to rag their juniors and create a warm

and friendly environment from them.

The teaching faculty and the administrative team together worked in unison and coordination to successfully conduct the program. The Programme ended with a vote of thank by Prof. Anilbhai Goel. Principal
